Oregon COVID-19 Projections

The current projection for Oregon is that our COVID-19 cases will peak on April 22. The projections for Oregon anticipate no hospital bed or ICU bed shortages but a possible ventilator shortage of 40. For comparison, New York's projected peak is today and they have a 9,000 bed shortage and a 5,008 ventilator shortage.

Masks Update

Medical/surgical masks are preferred over cloth masks when available for 2nd stage of labor. Some community midwives have had success ordering masks by calling the supplier first thing in the morning to place an order. OMC is looking into getting medical/surgical masks for midwives through the Oregon Health Authority. The current PPE recommendation for maternity providers working with well patients is to wear mask and face shield or goggles during second stage and practices/providers are deciding individually whether to wear masks with well patients during prenatal, labor, and postpartum care. Guidance about this in the US is not great because it is largely based on scarcity of PPE in hospitals. The CDC is currently recommending cloth masks for any contact outside your household.

order online at <u>infinityimages.com</u>. Each reusable face shield costs \$7.50, and I was able to order this morning and pick up my 3 face shields for my birth team the same day at their warehouse! I plan to wear this to births along with my mask and gloves at all times. I think midwives deserve to be as protected as possible and I love that this product is not wasteful. Also, by purchasing these face shields we are supporting a local business trying to help solve the shortage of PPE, which is awesome! Wishing you strong health and much courage~ Angela"
